



# The Northwest School Summer Camp 2025 Financial Aid Application

## Summer Camp Financial Aid

The Northwest School awards financial aid based on the need of the family.

If you are a current or incoming NWS family who has received a Financial Aid award for the 2024-25 or 2025-26 school year, your summer camp fees will be prorated at the same percentage as your aid award for applications received by April 15. After that date, applications will be considered only if funds are still available.

Because funding is limited, and we wish to provide aid to as many campers as possible, awards will be limited to one session of camp. Please note that aid is only available for Full or Half Day registrations (not boarding).

## Qualifications

Campers and families can qualify for financial aid in a number of ways:

- Eligible for free or reduced lunch
- Qualify for SNAP or WIC benefits
- Qualify for Medicaid or CHIP
- Child in Foster Care
- Receiving financial aid at a peer independent school
- Other state or federal assistance benefits

## Process

Financial Aid Application is due in the summer camp office by April 15, 2025. If you have more than one camper, please fill out one application for each.

If there are more qualified applications than we have funding to award, recipients will be selected via lottery. Applicants who are not selected will be placed on a waitlist.

By May 1, we will notify recipients of selection or waitlist status, and give instructions for enrollment. Registration must be completed by May 15, or financial aid may be cancelled and awarded to a waitlisted applicant.

Some classes or sessions might fill before financial aid is awarded, and an award does not guarantee enrollment. You may register for camp and select "Apply for Financial Aid" on the payment screen to reserve a space in a session and classes.
